Roundtable on Sustainable Business in Africa

During these times of economic hardship and stagnation in Europe, the developing world, and Africa in particular, represents the ideal partner to spur sustainable development.

high-level dialogue on "sustainable business", in the form of an online roundtable between the private and public sectors and with the participation of experts in the field, will convene online (www.acpbusinessclimate.org) at 10am on 3rd April 2012. The session, themed "What type of public-private partnership for sustainable business?", is part of a series of online discussions facilitated by the ACP Business Climate Facility (BizClim). The session will explore steps towards implementing sustainable business models, applicable in developing countries and particularly in Africa.

Including development goals in core business operations

In the interest of social stability and progress, many multinationals are prioritising sustainability in their models, placing it higher on their agenda. Indeed, the concept of Corporate Social Responsibility (CSR), whereby businesses integrate the economic, social, and environmental imperatives of their activities, is gaining currency internationally. Despite the absence of a



regulatory global sustainability reporting standard, large companies are increasingly reporting on their CSR activities.

Recognising the magnitude of ongoing societal and economic changes and believing that 'business as usual' is no longer a viable option, leading companies are now anticipating trends and aligning profitable business ventures with the needs of society. As a result, new, inclusive business models are emerging.

Identifying essential factors for the implementation of sustainable business projects

Inclusive business models are one way for the private sector to contribute holistic solutions to support the sustainable development of emerging economies in an increasingly urbanised, energy- and resource-constrained world – for the benefit of both developing countries and business. It is now well understood that companies should focus on their core competencies and strengths – this is vital to ensuring consistency within a company's portfolio. However, it is less clear how they can work with government agencies and development organisations to this end.

Discussion Themes

- 1) Incentives How does sustainable business create value in such a way as to represent an incentive for sustainability considerations to be competitively internalised into business models?
- 2) Regulation Has sustainability as a core concept of doing business gained sufficient traction to progress independently, or is a mandatory regulatory framework necessary for the success of sustainable business models? Is international coherence essential, or can individual nations successfully lead by example without damaging the competitiveness of their private sectors?
- 3) Corporate Social Responsibility What is the relevance of sustainability considerations within the context of CSR in the global economy, and can it play a role in governing global markets?

e-School under scrutiny in Ghana

The Federation of West Africa Chambers of Commerce and Industry (FEWACCI), with the support of the ECOWAS Commission and sponsorship from the ACP Business Climate Facility (BizClim), will hold a two-day e-School Regional Conference on 26-27th March at the Mensvic Hotel in Accra, Ghana, aiming to validate a new Public-Private–Partnership (PPP) model.

The initiative seeks to facilitate a better knowledge of the e-school initiative in the ECOWAS region and the identification of new Public-Private—Partnership (PPP) models for its implementation. The new PPP model will help tackle some of the challenges and constraints experienced in the demonstration projects. The Conference will lead to the preparation of a roadmap for implementing a concrete action plan for the roll-out of the accepted PPP model in Ghana and across the ECOWAS region with the involvement of the private sector.

A number of high-level education and technology specialists and professionals from the ECOWAS region will participate in the Conference, including former Education Minister of Ghana, ECOWAS President, and current Secretary-General of the African Caribbean and Pacific Group of States, Dr Mohammed Ibn Chambas; Prof Abdoulaye Maga, Director of Education, Science and Technology of the ECOWAS Commission, and Mr Lee Ocran, the Minister of Education of Ghana.
