#### **Foreword**

Trade is a major driver of growth and development. It is therefore important for ACP countries, most of which are small and vulnerable economies which do not have domestic markets, to enhance exports. However, enterprises in ACP countries are more and more marginalized from or remain at the bottom of global value chains with very low valueadded products. This is linked to many structural impediments supply-side constraints these countries are facing in achieving productive efficiency and competitiveness. On the demand side also markets are becoming more demanding as consumers place a high premium on quality, safety and innovation. With the gradual erosion of MFN tariff, non-tariff barriers have gained importance as instruments of trade policy. In this context, the importance of technical regulations, standards and conformity assessment as major factors of trade facilitation in both domestic and international trade have grown in importance.

However, the weakness of the quality infrastructure(QI) institutions (Standardization, Quality Assurance, accreditation/certification, metrology services) **ACP** countries and lack of their participation in international QI decision-making has created impediments for their trade with foreign countries and this despite

generous duty-free and quota-free market access to developed countries.

The TBT Programme was launched in April 2013 with the specific objective to strengthen capacity of ACP countries and regions to improve their QI and comply with TBT on the external market as well as to define and enforce legitimate and adequately harmonised technical regulations on the internal markets. After only 10 month of operation we are glad to note that our outreach activities have generated a wide interest and led to a large number of expressions of interest by ACP countries.

# TBT Programme in brief

The ACP-EU TBT Programme has been set up to address the capacity building needs of ACP countries in the field of Technical Barriers to Trade.

The Programme financed under



the 10th EDF intra-ACP envelope and managed by a dedicated Programme Management Unit (PMU) has a provision of €15 Million, duration of four years (2013-2017) and is meant to assist ACP countries to:

- Upgrade and Strengthen Quality Infrastructure;
- Empower economic operators and ex- port sectors to comply with technical regulations on export markets and;
- 3. Disseminate best practices, results and experiences.

#### **Expected Results**

- Enhanced capacity of national, regional and continental quality infrastructure institutions to address TBT issues
- Broadened capacity of economic operators to comply with Technical Regulations, Standards and Conformity Assessment Procedures
- Dissemination of best practices, results and experiences at intra-ACP level

# **TBT Programme Outreach Phase**

The Programme follows a demand-driven approach and during the first 6 months the PMU conducted several outreach activities to inform ACP Stakeholders of the opportunities under the Programme and to invite applications for capacity building assistance in the TBT area.

To this end the ACP-EU TBT Programme has organized and participated in a number of events in European and ACP countries, which have yielded fruitful outcomes in terms of requests for information or requests for assistance addressed to the PMU.



Among these events, two major regional seminars have been organized in the COMESA and ECOWAS regions in order to let the regions know about the existence of the TBT Programme, raise awareness and encourage the formulation of requests and projects.

In both regions the majority of the countries was represented and



expressed strong interest in the Programme at regional and national levels. In both regions, interest was expressed by both public and private sectors and focused on a number of areas such as: accreditation, certification, metrology, WTO TBT agreement, quality systems.

Technical Barriers to Trade is a category of non-tariff barriers to trade which includes measures relating to mandatory technical regulations and voluntary standards that define specific characteristics of a product such as: its size, shape, design, labeling / marking / packaging, functionality or

performance. These technical requirements are usually introduced by government authorities as policy instruments to achieve public policy objectives and among them we can highlight: protecting human health and safety, animal and plant life and health or the environment, or consumers safeguarding deceptive practices. While serving policy objectives, measures nonetheless have a trade effect and can represent major obstacles to the trade of other countries. This is the challenge that the ACP countries are currently facing: how to pursue national policy objectives. without creating unnecessary barriers to trade for other countries while at the same time developing competitiveness and expanding export potential in regional and international markets in full compliance with the technical and other requirements for their products. Therefore the ACP Secretariat is welcoming the ACP-EU TBT Programme, as a one of the key elements of the Joint Africa-EU Strategy, and is confident that the Programme will benefit the ACP Group as a whole.


